## Why a Mobile Clinic?

While our staff is out in the community, we observe unplanned pregnancies, domestic violence, homelessness, and relationship issues. Offering a Mobile Clinic in our region will boost our life-saving ultrasound services to the most vulnerable, while solving their transportation challenges.

Aspire Together has been helping women and families for 35 years. We provide hope and help when women and families need it most.

Our medical services include pregnancy testing, STI testing and limited obstetrical ultrasound. Our social services include counseling and individualized classes regarding pregnancy, parenting, healthy relationships, life skills and ongoing support to provide the best outcomes for Mom, baby and family.

In 1985 our founder UVM Medical Student Andy Smith, and several local churches, saw a need to provide a **Christ-centered** alternative to abortion. We provide emotional, spiritual and practical help, that is free of charge and confidential.

Our staff includes an OB/GYN Medical Director, R.N./Sonographer, Licensed Clinical Social Worker and Board-Certified Life Coach. For more information check out:
